Managed Care Contract Evaluation

There is strength in our numbers. DPG uses a “messenger model” for managed care contracting that disseminates rates to each dental practice, allowing each member to individually accept or reject the contract. DPG then executes the contract as a group and the network must accept all credentialed members. DPG reviews all contract language to ensure that dentists are protected from any adverse actions. Networks delegate credentialing to DPG.
